
This Assignment is made by the RTC without recourse and without representation or warranty.

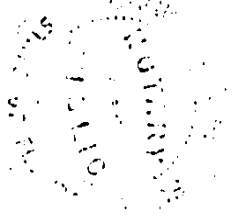
